

## Privacy policy and cookie statement Worxspace B.V.

The following privacy policy applies to all website visits, transactions, and agreements with Worxspace B.V. located at Mia van IJperenplein 82-84, 3065 JK, Rotterdam, The Netherlands, CoC: 89961374.

We respect the privacy of the visitors to our website and ensure that the personal information you provide to us is treated confidentially. How we do this exactly, and which personal data we collect from you for which purposes, can be found below.

### 1. The use of personal data

When using our website [www.worxspace.nl](http://www.worxspace.nl), we obtain certain data from you. These may be personal data. We only store and use the personal data that you directly provide to us, within the scope of the service requested by you (for example, via the contact form or for creating an account), or when it is clear at the time of submission that they are provided to us for processing. We will not use your personal data for other purposes unless you have given prior consent or unless we are permitted or required to do so under the law or the agreement.

### 2. Purposes of use

To ensure we can serve you optimally, it is necessary for Worxspace to store your personal data in certain cases. Worxspace uses your personal data for:

- Providing access to our website;
- Utilizing the functionalities on our website;
- Relationship management, including contacting you upon request;
- Obtaining insight into the use of our website;
- Product and service development;
- Determining strategy and policy.

### 3. Description of personal data

## **4. Retention periods**

We do not retain your personal data for longer than is necessary to achieve the purposes mentioned in this privacy and cookie statement.

## **5. Confidentiality & disclosure to third parties**

We handle your personal data confidentially. The personal data we collect via our website will not be provided to third parties for their direct marketing purposes. Furthermore, we will not disclose the data you provided to other parties unless you have given prior consent, it is necessary for the performance of a contract, or we are permitted or required to do so by law or agreement.

## **6. Data Security**

Worxspace utilizes meticulous security procedures to protect processed data, including measures to prevent unauthorized access by third parties. We ensure that only essential personnel have access to your data and that access to your personal information is restricted. We employ a TLS connection to achieve this security measure.

## **7. Cookies**

On this website, we use cookies to improve user experience and website functionality. Cookies are small information files that can be automatically stored or retrieved on your device (including a PC, tablet, or smartphone) when visiting a website. This process occurs via the web browser on the device. The information obtained by a cookie about your use of the website may be transferred to our secure servers or those of a third party.

On our website we use cookies to:

- To enable website functionalities (technical or functional cookies);
- To analyze website usage and improve the website based on that analysis (analytical cookies);

## **8. Technical or functional cookies**

The main purpose of cookies is to save you time and effort. For example, if you customize a web page to your personal preferences or navigate on a website, cookies remember the selected settings and preferences for future use. When you revisit the website later, the previously entered data can be retrieved by the cookies, allowing you to easily use the website's features as you had previously set them. We make use of the following technical cookies: Adobe API Fonts – Retention period: None.

## **9. Analytical cookies**

Additionally, cookies are used on this website to track statistics, allowing us to gain insight into the usage of our website and the effectiveness of our campaigns. We make use of the following analytical cookies: Google Analytics – Retention Period: 36 months.

## **10. Enabling and disabling cookies**

You have the option whether to accept cookies or not. Most browsers automatically accept cookies, but you can usually change your browser settings to disable cookies if desired (refer to your browser's help page for exact instructions). If you choose not to accept cookies, you
